

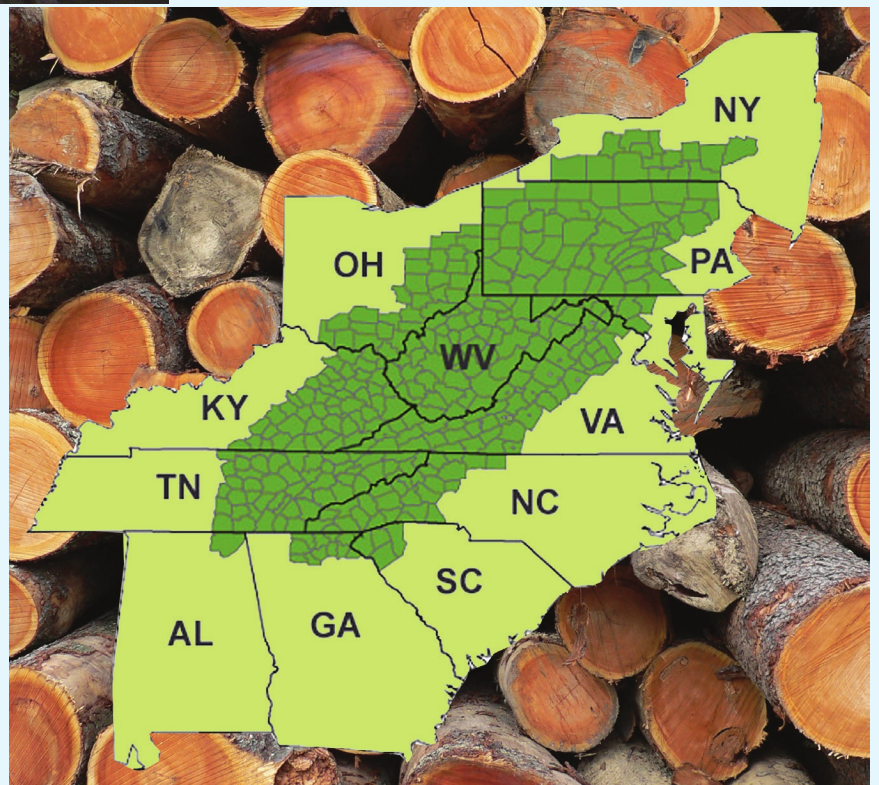

# Appalachian Hardwoods Are Legal & Sustainable Resource

The Appalachian Hardwood resource is growing at a rate of 2.8 to 1 for every tree that is harvested or dying combined, according to US Forest Service.

The growth is the result of modern forest management and wise utilization. Buyers of Appalachian Hardwood logs and lumber can be assured of this because of Appalachian Hardwood Manufacturers, Inc.

An analysis of USFS data finds the growth to removals ratio in the Appalachian forest has increased in the past 20 years.



The **Appalachian Hardwood Verified Sustainable** program began in 2007 to highlight companies producing, distributing and manufacturing sustainable goods from the region. The **Appalachian Hardwood Verified Legal** program began in 2011 for legality.

AHMI has developed the **Certified Appalachian Hardwood** in 2018 which uses a third-party company to audit members to standards that were approved by AHMI Trustees. This certification lists companies who purchase logs and lumber from the 344 counties of the Appalachian Region from northern Georgia through western New York. The region has 65.7 million acres of forestland and top species are Red Oak, White Oak, Hard Maple, Soft Maple, Cherry, Walnut, Hickory, Birch, Beech, Basswood and Yellow Poplar.

Certificates are available from member companies that explain the program and participation.

AHMI is a regional trade association headquartered in High Point, NC. Its mission is to promote the hardwood products from the Appalachian Region.
